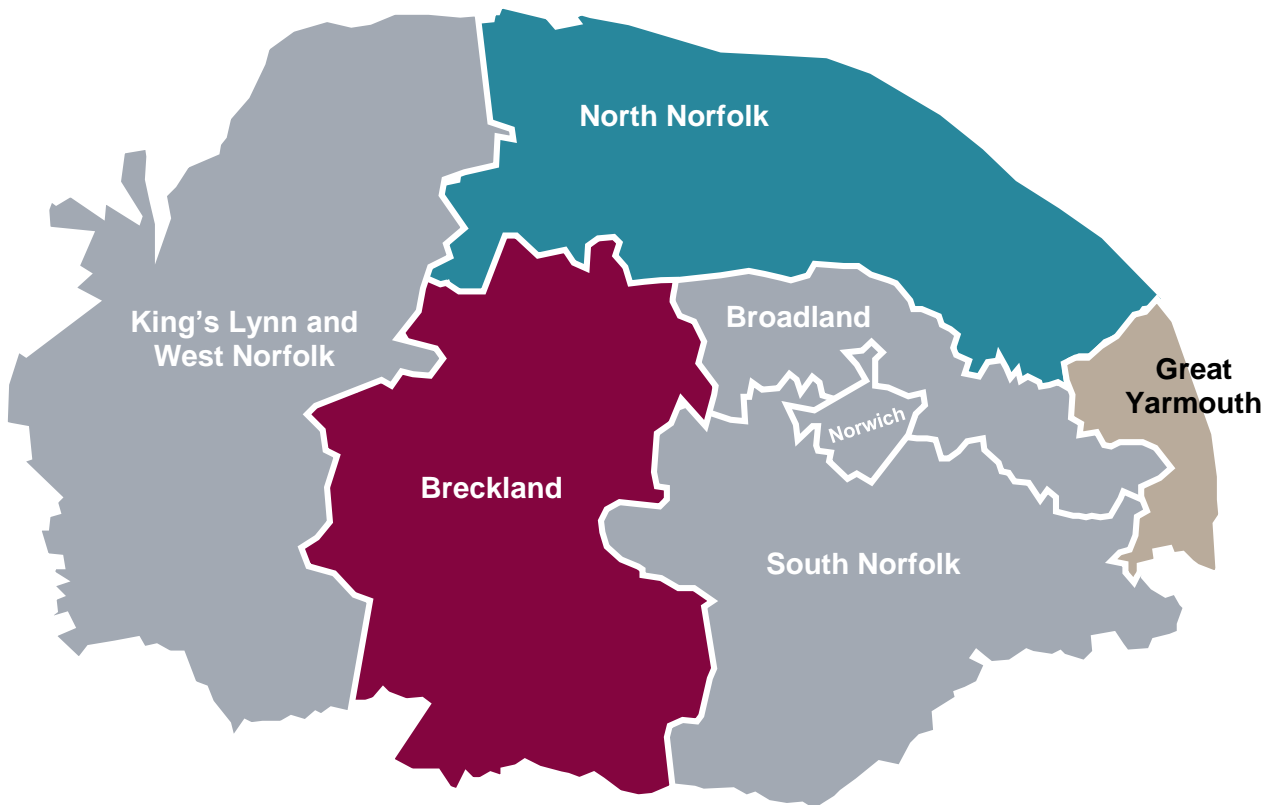

LOCAL AUTHORITY	CURRENT POSITION
Breckland	<ul style="list-style-type: none">- The Breckland Local Plan was adopted 28th November 2019.- There is currently no commencement date for the next 'Call for Sites'.
Broadland	<ul style="list-style-type: none">- The current Local Development Plan is the Joint Core Strategy DPD (for Broadland, Norwich and South Norfolk) adopted in 2011; a series of amendments were adopted in January 2014.- The emerging Greater Norwich Local Plan Regulation 18 Draft Plan Consultation is currently being undertaken from 29 January 2020 - 16 March 2020.- Adopted is currently scheduled for September 2021.
Great Yarmouth	<ul style="list-style-type: none">- The Local Plan Part 1 (Core Strategy) was adopted by Full Council on 21 December 2015.- The Council is currently preparing the 'final' Draft Local Plan Part 2. This is expected to be available for public consultation in early 2020. This Draft Local Plan Part 2 is then anticipated to be submitted to the Secretary of State in the late Spring of 2020. The expected adoption for this document is December 2020.- The New Local Plan (2021-2041) is expected to carry out the 'Call for Sites' in Autumn 2021.- The expected adoption date for the emerging Local Plan is Autumn/Winter 2023.
King's Lynn & West Norfolk	<ul style="list-style-type: none">- The Core Strategy is a document, which forms one part of the Local Development Framework, was adopted in 2011.- Currently under Local Plan review up to 2036.- The draft Local Plan review was published for an eight-week consultation period from the 4 March to the 29 April 2019.- The Local Plan review is due to be adopted in the Spring months of 2021.
North Norfolk	<ul style="list-style-type: none">- The current Local Plan comprises the Core Strategy & Development Management Policies.- The Council produced its First Draft Local Plan Part 1 consultation in May/June 2019.- The First Draft Local Plan (Part 2) consultation date is to be confirmed.- The adoption date is expected November 2020.
Norwich	<ul style="list-style-type: none">- The current Local Development Plan is the Joint Core Strategy DPD (for Broadland, Norwich and South Norfolk) adopted in 2011; a series of amendments were adopted in January 2014.- The emerging Greater Norwich Local Plan Regulation 18 Draft Plan Consultation is currently being undertaken from 29 January 2020 - 16 March 2020.- Adopted is currently scheduled for September 2021.
