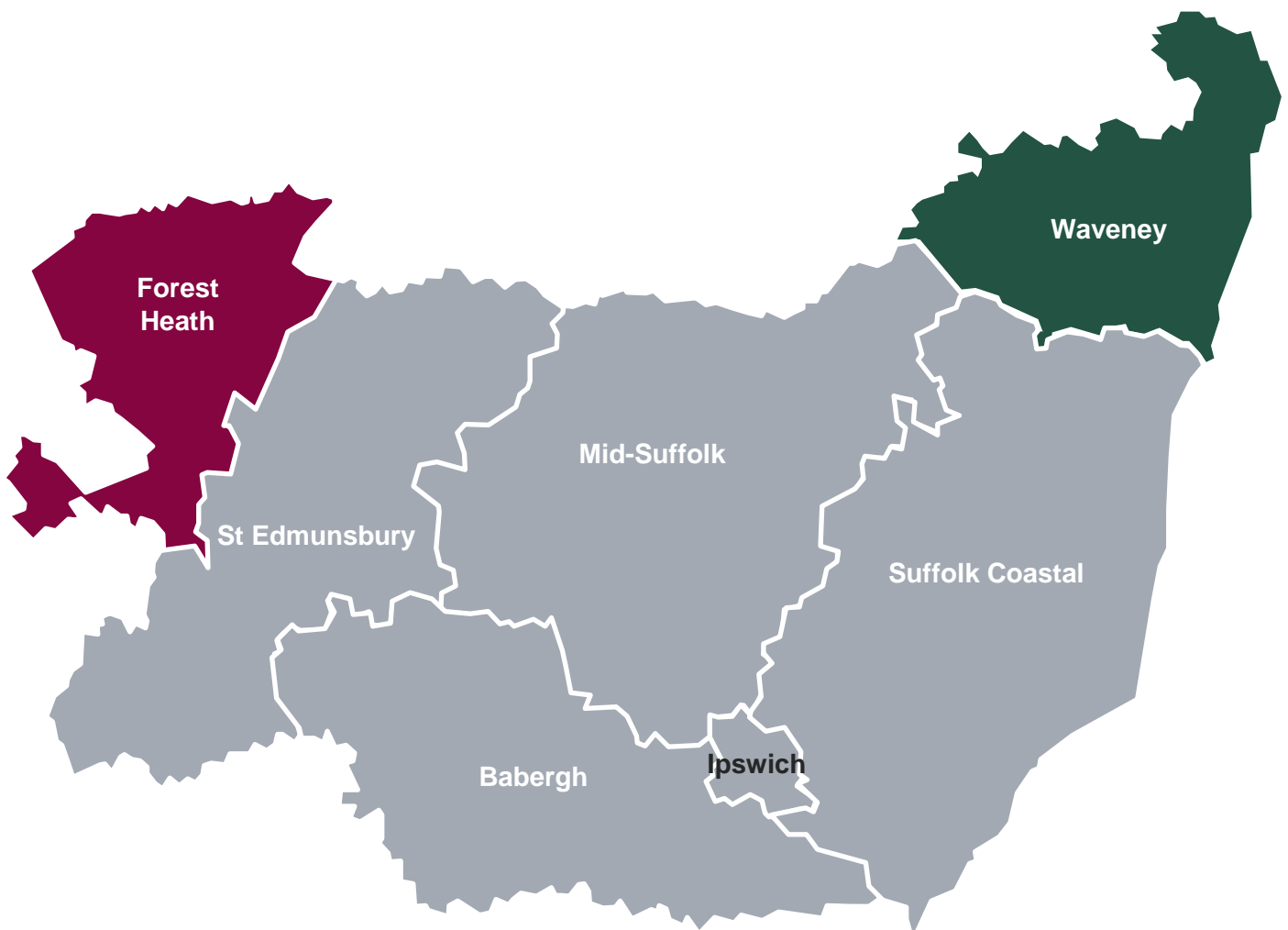

**LOCAL AUTHORITY****CURRENT POSITION****West Suffolk  
(Forest Heath)**

- Forest Heath Local Plan documents submitted to the Secretary of State on the 24<sup>th</sup> March 2017. These comprised the Single Issue Review (SIR) of Core Strategy Policy CS7 Overall Housing Provision and Distribution and the Site Allocations Document.
- Modifications Examination Hearings took place in June 2018.
- No further information currently from the Council.

**West Suffolk (St. Edmundsbury)**

- The St. Edmundsbury Local Plan consists of the Core Strategy (2010), Vision 2031 (2014) comprising Bury St Edmunds Vision 2031, Haverhill Vision 2031 and Rural Vision 2031, and the Joint Development Management Policies (2015).
- The Council do not yet have a date for the review of the adopted Local Plan and have stated that they will be deciding a date upon adoption of the Forest Heath Local Plan.

**Ipswich**

- The Ipswich Local Plan was adopted on the 22<sup>nd</sup> February 2017.
- The adopted Local Plan comprises of the Core Strategy, Policies Development Plan Document (DPD) Review, Site Allocations and Policies DPD and the Policies Map.
- The Council are currently working on their Local Plan Review along with Suffolk Coastal District Council and Mid-Suffolk & Babergh District Council.
- The Local Plan Review Issues & Options ran until the 30<sup>th</sup> October 2017.
- Regulation 19 Consultation of the Local Plan Review is scheduled for Summer 2018. This has not been mentioned at any recent Committee meetings.

**Mid-Suffolk & Babergh**

- Public Consultation on the Issues & Options Document ran until the 10<sup>th</sup> November 2017.
- Pre-Submission (Regulation 19) document – Council's hoping to publish in late summer 2018. This is behind the Local Development Scheme which states Winter 2017/18. The Pre-Submission Document has not yet been published.

**East Suffolk  
(Suffolk Coastal)**

- Public Consultation on the Issues & Options document ran until the 30<sup>th</sup> October 2017.
- The First Draft Local Plan Consultation began on the 20<sup>th</sup> July 2018 and ran until the 14<sup>th</sup> September 2018.
- The Submission of the Plan for examination is estimated for February 2019.
- Adoption of Plan by the Council is estimated for November/December 2019.

**East Suffolk  
(Waveney)**

- The Local Plan document was submitted to the Secretary of State for independent examination on 22<sup>nd</sup> June 2018.
- Examination hearings are scheduled for October 2018.
- Inspector's report and Adoption expected for January 2019 and March 2019, respectively.
