Cambridge	<ul style="list-style-type: none"> - The Cambridge Local Plan was adopted in October 2018. - The Greater Cambridge Shared Planning Service has formally announced it will commence its 'Greater Cambridge Local Plan – The First Conversation' consultation, starting on 13 January 2020 and running until 24 February 2020. - Adoption of The Greater Cambridge Local Plan is currently timetabled for Summer 2023.
East Cambridgeshire	<ul style="list-style-type: none"> - The East Cambridgeshire Local Plan was adopted in 2015. - In February 2019, the Council withdrew its emerging Local Plan. The East Cambridgeshire Local Plan 2015 remains the adopted Local Plan for the district. - There is currently no specific timetable for preparation of a new plan.
Fenland	<ul style="list-style-type: none"> - The Fenland Local Plan was adopted in 2014. - The Council are at the first stage in the process of preparing a new Local Plan. Fenland District Council consulted on its Issues & Options document from 11 October and 21 November 2019. - The adoption date for the emerging Local Plan is currently timetabled for February 2022.
Huntingdonshire	<ul style="list-style-type: none"> - The Huntingdonshire Local Plan was adopted in May 2019.
Peterborough	<ul style="list-style-type: none"> - The Peterborough Local Plan was adopted 24 July 2019.
South Cambridgeshire	<ul style="list-style-type: none"> - The South Cambridgeshire Local Plan was adopted in September 2018. - The Greater Cambridge Shared Planning Service has formally announced it will commence its 'Greater Cambridge Local Plan – The First Conversation' consultation, starting on 13 January 2020 and running until 24 February 2020. - Adoption of The Greater Cambridge Local Plan is currently timetabled for Summer 2023.
